NOW THIS DEED WITNESSETH

In pursuance of the above and in consideration of the mutual rights and obligations arising therefrom the Author of the Trust does hereby constitute and declare a trust on the following terms and conditions:

1. The name of the Trust shall be SRI. AUROBINDO TRUST (BANGALORE).
2. The office of the Trust shall for the present be located at Jaya Bhavan, No. 8-9 Gangadhar Chetty Road, Bangalore - 560 042. It is left to the discretion of the Trustee/s to shift the office of the Trust to any other place.
3. The beneficiary of the trust shall be Sri. Aurobindo Society, a registered body with its office presently at Sri. Aurobindo Bhavan, 8 Shakespeare Sarani, Calcutta - 700 016.
4. The said Sri. Aurobindo Society being the sole beneficiary of this Trust the objects of this Trust shall be to carry out the objects of the said Sri. Aurobindo Society, the sole beneficiary herein.

5. H. R. H. PRINCESS TARA RAJYA LAKSHMI DEVI, shall be the First Trustee as well as the Managing Trustee of the Trust. She shall have all the powers to coopt one or more persons as additional Trustees. In the event the aforesaid H R H PRINCESS TARA RAJYA LAKSHMI DEVI resigns or is incapacitated to act as Trustee or in the event of her death, the succession to the Trusteeship shall be as mentioned below and he, as and when he becomes a trustee will have the same powers that have been conferred upon the original Trustee in these presents:

Sri. Navajata, son of the late Sri. Ramnarain Poddar of Sri. Aurobindo Society, Pondicherry, presently at Bangalore.

6. The AUTHOR OF THE TRUST is the owner of the immovable property known as Jaya Bhavan and bearing Municipal Nos. 8 - 9 Gangadhar Chetty Road, Bangalore - 560 042, which property is more fully described in the schedule hereto and is herein after referred to as the schedule property.

7. Subject to the permission being granted by the Reserve Bank, Income Tax and other government authorities, the AUTHOR OF THE TRUST does hereby declare that the schedule property will become the property of the Trust and the same vesting in her as the First Trustee for and on behalf of the Trust on the 15th June 1979. On and from the said day the schedule property shall be the Trust property

8. The Trustee/s shall apply all trust funds and other assets, income, etc., to further the objects of the Trust.

9. In relation to their work, the trustee/s shall be guided by a set of working rules prepared by mutual consent and with the approval of the Chairman, Sri. Aurobindo Society, Pondicherry. The working rules may provide for altering the number of trustees, the appointment, co-option, resignation, termination, etc., of the trustees, the manner in which the trustees will discharge their work, etc.

10. The Trustee/s shall take up the work of the trust which shall be to give effect to all or any of the objects of this Trust. The Trustee/s as a matter of principle shall have the concurrence of the Chairman, Sri. Aurobindo Society, Pondicherry, for all activities undertaken by her/them.

11. The Trustee/s shall be at liberty to make investments, acquire and dispose of movable and immovable property belonging to the trust by way of purchase, gift, lease, exchange, sale, etc. and otherwise act in relation to the trust funds and/or property in any manner of their choice as long as according to her/their subjective satisfaction the same is necessary to achieve the objects of the trust. The Trustee/s shall be at liberty to secure funds by way of donations, grants, subscriptions and to raise loans from Government, banks

or any other lending agency and also to offer as security any trust property whenever necessary for purposes of the trust. The trustee/s is/are at liberty to open and operate bank accounts and also to appoint attorneys and/or agents to act ~~on her/their behalf. This trust is irrevocable~~ and the author of the trust has no interest and has not reserved any interest in the trust (schedule) property or the income therefrom.

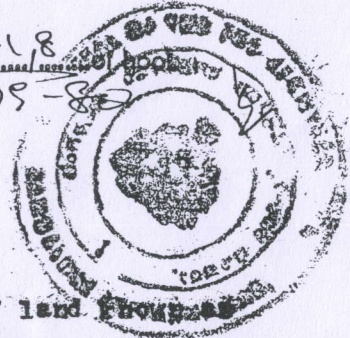
12. At any time, the Trustee/s herein may, by unanimous decision, determine the trust and hand over the trust property to the beneficiary herein who shall become the absolute owner of the same. The term trust property shall mean and include the schedule property and all benefits arising therefrom along with its additions and accretions and other assets, movable and immovable of the Trust of any kind representing the income and benefits of the Trust.

13. In all matters not herein specifically or generally provided for, all parties concerned will be governed by the law in force and as applicable to such matters.

14. The term trustee shall mean and refer to any person who occupies the position and office of the Trustee at any time and the term beneficiary herein, its successors, assigns and legal representatives.
